**All visitors must present a Photo I.D. each time they visit. Initial visits require proof of U.S. Citizenship status. The following are acceptable forms of US citizenship status verification:**

- Valid or expired US passport book or card
- Copy of US Birth Certificate (state-issued)
- Naturalization Certificate
- US Customs and Immigration Service Permanent Resident Card (Green Card)
- US Government-issued credential (e.g., Common Access Card (CAC))
- Defense Information Security System (DISS) visit request
- Signed Corporate letter or memo stating visitor is a US person

**\*\*NOTE:** If the form being used to verify citizenship status includes a photo, it will also meet the requirement for a photo ID and a 2nd form is not needed. Photo ID is required every subsequent visit.
